Enrollment in NPTEL Course for Mandatory NPTEL/MOOC

In accordance with the directives mentioned above, all students of PGDM- Regular & ODL of Tecnia Institute of Advanced Studies CDL are hereby instructed to enroll in NPTEL courses for the List of January 2024 Semester Course, for Mandatory NPTEL/MOOC as per the curriculum. Those who have not yet done so are urged to complete their enrollment as early as possible, before 29th January, 2024. Many courses will commence from 22nd January, 2024. Registration for examinations has also commenced for some courses.


- ❖ Please consult the concerned department for preferred course/subject names and durations. Additionally, while enrolling in the course and registering for examinations, it is mandatory to write the complete Registration Number in place of the Roll Number.
- ❖ All students must select Tecnia Institute of Advanced Studies as the Local Chapter and choose 'Yes' for sharing information with the institute. Individual students will be held responsible for any consequences arising from failure to do so.

NPTEL recommended Credit according to the duration of the course is as follows:

- 4 Week Course → 1 Credit
- 8 Week Course → 2 Credit
- 12 Week Course → 3 Credit

For example: - If the curriculum has 3 credit MOOC courses, a student must be enrolled in a 12-week course and so on as above.

During the PGDM- Regular & ODL Course (2 years), all students have to score 12 Credit Points; unless the PGDM Certificates will not be issued. It is mandatory for all the students.
