## MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is entered into on the 04<sup>th</sup> day of March, 2024

### BY AND BETWEEN

**Tecnia Institute of Advanced Studies - CDL (Standalone Institute)**, B-71/2, Wazirpur Industrial Area, Wazirpur, New Delhi - 110052 (thereafter called TIAS-CDL) (Approved by AICTE, Ministry of Education, Govt. of India)

**Sanskriti University, Mathura - Delhi Highway, Chhata, Mathura (U.P.)**, (hereinafter called SU) collectively the "parties".

### 1. Objective of the MoU

The general objective of this Memorandum of Understanding (MOU) is to stimulate and facilitate the development of collaborative and mutually beneficial programs which serve to enhance the intellectual life, social sensitization and cultural development of both organizations.

### 2. Areas of Collaboration

The Two Educational Institution will:

- a) Promote Joint teaching programs. Research activities and publication i.e. to explore possibilities of refresher programmes in interdisciplinary areas of specialization of high relevance to both the Institutions such as the area of Management, Computer Science and Mass Communication.
- b) Provide copies of tangible document through the interlibrary load services to the libraries of both. If requested.
- c) Permit scholars of TIAS - CDL & SU to physically access the library of both the Institution after prior permission for research purpose from the host Institution.
- d) Provide virtual exchange of Journals for research and development.
- e) Provide professional development to faculty members of TIAS - CDL & SU through extending invitation for participation in conferences, seminars, workshops and Faculty development programs organized by each other.
- f) Promote Academic Visits/Exchange of Faculty i.e. planning and handling of academic programs and courses. Exchange of mutual experience in teaching, research and industrial practice.
- g) Promote exchange of students through organization of study visits and training, Participation in Bachelor's, Masters', and Doctoral courses, guidance and supervision of student's theses and projects works.
- h) Promote organizing the cultural and sports activities together for the students of TIAS - CDL & SU.

  


  


### 3. Terms and Conditions

- i. In any of the activities mentioned above, wherever financial aspects are involved, amount, payment conditions, etc. would be spelt out clearly before starting the activity.
- ii. This MoU may be amended/ modified by mutual written agreement of TIAS - CDL and SU at any time.

### 4. Confidentiality

- i. TIAS and SU agree to hold in confidence all information/data designated by the parties as being confidential which is obtained from either of the parties or created during the performance of the MoU and will not disclose the same to any third party without written consent of the other party.
- ii. The above confidential clause under this MOU excludes the information/data possessed by either party before entering into this MoU or independently developed and/or information already available through public domain.

### 5. Duration of MoU

This agreement will take effect from the date of its signing and shall be valid for five years from that date unless sooner amended/modified by mutual written agreement between both Parties, and may be extend by mutual written agreement.

Either party may terminate the Agreement at any time during the term by the provision of three month written notice to the other party.

We hereby declare that the contents of this undertaking and agreement are true to the best of my knowledge and no part of the agreement is false and nothing has been concealed or misstated therein.
